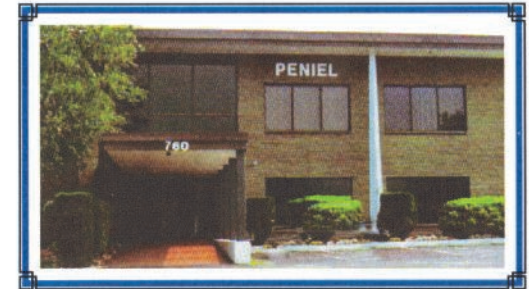

15. Proper attire is required by all visitors. Halter tops are not permitted. Shorts and skirts must be to the knees, and no tight-fitting or suggestive clothing is permitted.

PENIEL'S ON PROPERTY VISITOR'S POLICY

1. All visitors over the age of (12) twelve must show a valid picture identification upon entering the facility. They are also required to sign the visitor's log. Sorry, there are no exceptions.
2. All visits will be limited to (4) four people who are chosen by the resident and are approved by the Case Board.
3. Due to the confidentiality law requirements, no cameras, photo phones, camcorders or tours are permitted.

Visitors are not permitted to interact with other clients in the program. This includes exchanging telephone numbers, addresses or distribution of business cards or other forms of identification.
4. The use of cell phones is not permitted on property. However, Peniel's pay phone is available for emergencies. Simply ask the staff on duty to direct you to the location. Visitors should utilize phones off property for extended or personal calls.

5. Saturday is visiting day. Visiting hours are from 10:00 a.m. to 1:00 p.m. All visits promptly conclude at the designated time, hopefully without reminder or incident.
6. Children must be under the control of the parent or guardian at all times. If Peniel's property is damaged or destroyed, the guardian will be responsible to pay the repair or replacement cost within 15 days.

A client will not graduate until all outstanding accounts are resolved. Cost of replacement may be added to treatment fees.
7. Parents and guardians are advised to bring appropriate toys for children in need of being occupied during the visit. Reminder: children are not permitted to touch equipment or destroy Peniel's property.
8. Clients and visitors must remain in the designated visiting area.

Because this is a mini-security facility, if a visitor leaves the facility for any reason, the visit is automatically terminated.

9. Visitors may only bring approved "Ready To Eat" foods in the facility. All the foods must be brought in the facility when the visit begins. All beverages must be in original sealed containers. All items are subject to search.

All remaining food, beverages and any trash items must be removed by the visitor at the end of the visit. There are no exceptions to this policy. The area must be clean at the end of visit.
 10. Remember that the Peniel client is responsible to make sure their visiting area is cleaned up prior to the end of the visit and before returning to the dorm. Failure to clean area will result in disciplinary action.
 11. Please be advised that students may not personally receive packages, gifts, money, clothing, or exchanges of any kind during a visit. Please see staff.

All boxes-packages must be sent to the student through UPS or Federal Express. Letters may be mailed through the regular postal service. There are no exceptions.
